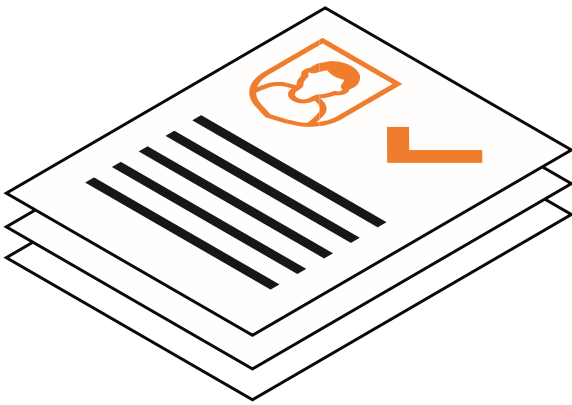

Privacy Policy



Commitment to Te Tiriti o Waitangi

Waiuku Yacht Club recognises Te Tiriti o Waitangi as Aotearoa New Zealand's founding document.

Waiuku Yacht Club is committed to upholding the mana of Te Tiriti o Waitangi and the principles of Partnership, Protection and Participation.

Values

Waiuku Yacht Club knows you care about how your information is used and shared. It is committed to ensuring your privacy is protected and your information is only used appropriately.

Purpose

This policy aims to help people involved in **Waiuku Yacht Club** understand how their personal information may be used and stored by **Waiuku Yacht Club**.

Application

This policy applies to all people providing personal information to **Waiuku Yacht Club**.

Personal information means information about a person.

Collection, use and storage of personal information

Collecting personal information

When you become a member of, or participate in **Waiuku Yacht Club** activities, **Waiuku Yacht Club** will need to collect some personal information from you (or family/whanau of children). It may also collect other information needed to perform its functions, or where required by law.

Personal information may include your contact details and any other personal information that you provide. For participants, this may also include performance results and health/medical information.

Waiuku Yacht Club may collect this information directly from you with your permission, or from the regional organisation and/or national organisation to which

Waiuku Yacht Club belongs, other organisations which are affiliated to it, for example New Zealand Olympic Committee, Paralympics New Zealand and Drug Free Sport New Zealand.

Using personal information

Waiuku Yacht Club

Waiuku Yacht Club will never sell your personal information. Employees of

Waiuku Yacht Club may have access to your personal information to do their work. Their access to your personal information is limited to what is necessary.

Agents and subcontractors of

Waiuku Yacht Club may have access to personal information needed to do their work but may not use it for any other purposes.

From time to time **Waiuku Yacht Club** may take photos or video of club sailing activities and use them for Waiuku Yacht Club promotional material, social media and on the Waiuku Yacht Club website.

Waiuku Yacht Club may be required to share your personal information with the community, regional and/or national organisations it belongs to, other organisations which are affiliated to it that you belong to or have applied for membership, for example Drug Free Sport NZ, Sport New Zealand, High Performance Sport New Zealand, the NZ Olympic Committee and Paralympics New Zealand.

Your personal information may be used:

- for **Waiuku Yacht Club** activities and operations
- to consider an employment or volunteer application
- to amend records to remove or update personal information
- for other everyday business purposes that involve use of personal information
- to comply with the law; or protect our rights, property, or safety, or that of our members, or others.

Storing and disclosing personal information

Waiuku Yacht Club will maintain all reasonable protections against the loss, misuse or inappropriate disclosure of your personal information, and maintain processes to prevent unauthorised use or access to that information.

Waiuku Yacht Club will keep all physical documents secure, both inside and outside its premises.

Waiuku Yacht Club will keep electronic personal information secure by making sure its data storage is protected from external sources, maintaining regular back up and applying good security practices.

Waiuku Yacht Club may use cloud computing. Where used, **Waiuku Yacht Club** will ensure that cloud computing solutions meet good practice security requirements.

Requests for personal information

You have rights to access and correct your personal information (or your children's) in accordance with the Privacy Act 2020. If you want to access or correct your personal information (or your children's), please contact the Privacy Officer.

Waiuku Yacht Club Privacy Officer

Waiuku Yacht Club will not disclose information about children to family/whanau unless there is a clear legal right to access that information.
